HUNT CONTRACT TERMS AND CONDITIONS

A hunt booking is confirmed only upon receipt of a 50% deposit of the daily rates and photo identification of the parties of the hunt. Failure to remit these items may result in the release of the desired hunt dates and possibly the inability to reinstate a reservation. By paying the deposit, and sending proof of identification, you the client, and Morani River Ranch, LLC are bound under contract, for the dates stipulated in your hunt contract.

Deposits are NOT REFUNDABLE with less than a twelve (12) month notice. The principle of a deposit is to confirm arrangements between you the client, and Morani River Ranch, LLC, and constitutes acceptance and confirmation of a commitment made by both parties. In the event of a cancellation, the client will either forfeit the deposit in total to cover the total loss of a hunt booking, or the client may reschedule his hunt to a later year. Should the client wish to reschedule the hunt, a written request must be received by Morani River Ranch, LLC no less than 180 days prior to the original hunt date. In the event of an agreed postponement between the client and Morani River Ranch, LLC, the deposit will be put towards the new hunt dates, with the knowledge that there will be adjustments to the future pricing due to market fluctuations.

If you the client, are a no-show, Morani River Ranch, LLC will treat your reservation as cancelled and all payment will be forfeited.

No refunds will be given for:

- Lost travel time or substitution of facilities
- Itineraries amended after departure
- Circumstances arising above and beyond the control of Morani River Ranch, LLC, making alternate arrangements necessary to ensure the safety and/or further enjoyment of your hunt
- Leaving your hunt early

Morani River Ranch, LLC strongly recommends that you obtain insurance for trip cancellation, major medical, accidental death and disability, loss/damage of personal affects and emergency medical evacuation.

HUNT RULES

- No drinking while hunting - NO EXCEPTIONS
- If an animal is wounded (Morani guide's judgement) or if blood is found-full price is due on the animal
- No one hunts alone-you will be accompanied by a Morani guide at all times
- Off-limit animals are not to be hunted, harvested or harassed in any way
- No animals are to be hunted in the house pasture, within site of the ranch compound. This includes Axis & Longhorn feeder and the Ranch Manager's home, the barn and the area within site of the stables
- Any damages to ranch property, vehicles, gates, equipment, etc. are to be paid for by the party responsible
- All hunters and guests must sign waivers
