DAILY RATES AND INFORMATION

DAILY RATES

The daily rate is \$495. per day per hunter and/or fisherman. This includes lodging, meals and ranch guide. Charge applies to *any* days hunted and/or fished, and applies even to IN OUT days and partial days. Observers are \$295. per day, with a maximum of two (2) observers per hunter/fisherman. All wounded game will be paid for at trophy rate. Tips to guides are not included-5%-10% of trophy fee is recommended. Trophy status is decided by the ranch guide. Non-trophy, are animals with no trophy potential, as solely determined by the ranch guide. The guide's measurement of the animal, determines the trophy pricing and is NOT negotiable. Daily Rates do not include trophy fees, license fees, ammunition, taxidermy, transportation or game processing. Day in and day out rates for half days are \$295. per person (Full \$495. rate applies if hunting and/or fishing on the in out days).

MEALS AND LODGING

We offer first class lodging including all meals and beverages. We are fully prepared to meet any special preferences or dietary requirements with advanced notice. All ranch accommodations feature private bedrooms, suites and full private baths.

HUNTING LICENSES

Hunting licenses are required by the Texas Parks and Wildlife Department, for both native and exotic game. If you are a Texas resident, the general hunting license will cover both types of game and is currently available for \$23.

Non-resident, annual hunting licenses are available for \$300. for native game and \$125 for exotic game, or there is a 5 day, exotics only license at a cost of \$45. Non-resident hunters under the age of 17, may purchase a general, non-resident license (valid for native as well as exotic game) for \$6.

Please note that license fees are subject to state regulation and may change from time to time. It is the sole responsibility of the guest to acquire the proper licenses. Morani Ranch staff is NOT responsible for the acquisition.

HUNT BOOKING AND DEPOSITS

We hunt 365 days a year, and you may book a hunt at any time. Please bear in mind that all hunts are booked on a first come, first serve basis. The earlier you book your hunt, the more likely it will be, that the dates you are requesting will be available.

We will make every effort to accommodate your plans and schedules.

Hunt dates are confirmed upon receipt of 50% deposit of your daily rates, a copy of a photo identification and a completed, signed and notarized contract. Deposits are fully credited to your hunt and are non-refundable if the hunt is cancelled for any reason.

In the event of a cancellation, the deposit will be fully credited to another hunt within a year of the deposit receipt.

All costs and fees are quoted and payable in US dollars. All fees and costs must be paid in full prior to leaving the ranch. We accept cash, traveler's checks or electronic funds transfer. **Personal checks and credit cards are NOT accepted.**

There is no guarantee that the hunter will acquire any animal on a hunt.
